# PURPOSE

The National Industry Awards are an opportunity to recognise and reward excellence within the Australian Bus and Coach Industry.

The purpose of this framework is to provide clarity around the Award categories, eligibility the award nomination criteria's, the nomination process and the judging process.

# NOMINATIONS

Nominations must be received using a BIC approved nomination form, available at [www.bic.asn.au/awards](http://www.bic.asn.au/awards).

# JUDGING

Nominations will be assessed by the BIC Council (or a delegated body) and will be individually ranked according to the award criteria.

- checked for eligibility, membership status
- how the nominee has made a demonstrable contribution to the Award Vision
- how the nominee, or the team they lead, excelled in their field.

The highest-ranking nominee will be awarded the winner.

# CEREMONY

The awards are presented at the Bus Industry Confederation (BIC) National Conference.

# CRITERIA

- All nominators and nominees MUST be a current financial member of The Bus Industry Confederation (BIC), QBIC, TasBus, BusNSW, BusSA, BusVIC and/or BusWA within the 2025/2026 and 2026/2027 Financial Years.
- All nominations MUST be received using the approved BIC nomination forms, available at [www.bic.asn.au/awards](http://www.bic.asn.au/awards). All criteria must be addressed to be found eligible.
- Current BIC Councillors, Secretariat or members of the 2026 judging panel are NOT eligible for nomination.
- \*\*Denotes a mandatory field and must be answered.
